Dear friends and delegates

#### **Zone 1 Financial Accounts 2016**

Delegates are requested to note the audited Financial Accounts for 2016 presented in Appendix A. Delegates are also requested to note the deficit for the year of 1358.85 EUR.

In consideration of these Accounts, Delegates should note the following:

- Whilst Income from Entry fees received during the year was some 1,459.00 EUR less than during the previous year, total tournament entries during the year rose by 123 from the previous. It should be noted that Direct Entries as a proportion of total entries rose from 35% to 41%
- One extraordinary item to be noted in these accounts is the contribution of 5,000 EUR made to ICCF to assist with costs of Server Development.
- 3. I can confirm that the large majority of our Member Federations arrange prompt payment of fees and that at 14 August only 1 Member Federation had yet to make payment of fees for 2016

Delegates are respectfully requested to approve these Accounts.
